- As the video plays, illustrations of individuals show on the screen. The speaker of the video is a Black woman with cornrows. The images show her walking through different settings – fields, cities, at the Capitol Building in DC, etc. as she speaks about your rights for services.
- Questions she asks that show up on the screen for self-reflection:

- Do people listen when you speak up for yourself?
  - Are you able to have personal space and alone time?
  - Are you able to come and go in your home as you please?
  - Are you able to have visitors where you live?
  - Did you choose the services you receive and where they are provided?
  - Did you choose who provides your services?
  - Did you choose where you live?
  - Did you choose who you live with?
  - Do you have a chance to make decisions about your life and what you want to do?
  - Do you choose what you do for fun?
  - Are you able to choose your own schedule?
  - Do you choose how to spend your money?
  - Do you spend time in places where other people living in your community go?
  - Do your service providers support you to do what you want in the community?
  - Do you get to do as much as you want in your community?
  - Can you be in the community when you want to?
